## Ceranamel™ XT-40S 40 Year Limited Warranty

Dura Coat Products, Inc. provides the following warranty concerning the use of Dura Coat's Ceranamel XT-40S coil coating paint system for metal building panels and accessories to:

## Metallion Industries, Inc. 850 NW Park Avenue Estacada OR 97023

Dura Coat Products, Inc. (Dura Coat) warrants to **Metallion Industries, Inc.** ("Metallion") that the Ceranamel XT-40S ("XT-40S") Coil Coating System, including primer and backer, when applied over properly cleaned and chemically treated Aluminum, Hot Dipped Galvanized Steel, and Aluminum-Zinc coated steel in accordance with Dura Coat Products Inc. application and XT-40S data sheets, will not under normal atmospheric conditions, in the United States and Canada:

- A. Crack, Check, or Peel for a period of (40) forty years from date of installation (except for such crazing that may occur on tightly roll-formed edges and brake bends).
- B. Chalk in excess of a numerical rating of (8) for a period of (30) thirty years from date of installation when measured in accordance with the standard procedures outlined in ASTM D-4214 on vertical (sidewall) surfaces. On horizontal application (roofing), chalk will not exceed a-numerical rating of (6).
- C. Fade or change color in excess of (5) E units (NBS) for vertical (sidewall) surfaces and seven (7) for non-vertical (roof) surfaces, for a period of (30) thirty years from date of installation as calculated in accordance with ASTM D-2244, Paragraph 6.3. Color change is to be measured on an exposed painted surface that has been cleaned of surface soils and oxidation, and the corresponding values measured on the original or unexposed painted surface. It is understood that fading or color changes may not be uniform if the surfaces are not equally exposed to the sun and elements.

## THIS WARRANTY IS SUBJECT TO THE FOLLOWING CONDITIONS:

1. This warranty is restricted to failures resulting from normal weathering and does not include coating failures caused by scratches, scrapes or any other unnatural damage including improperly formed, fabricated or embossed material. Dura Coat accepts no liability for damages caused by acts of God, radiation, falling objects, explosions, or other external forces beyond Dura Coat's control. This warranty does not cover any kind of substrate corrosion, including corrosion at the cut edges of a building panel.

- 2. Dura Coat does not accept damage to the XT-40S occasioned by moisture or other contamination detrimental to XT-40S attributable to improper storage prior to installation, damage to XT-40S occasioned by condensation attributable to improper packaging, handling, shipping, processing and or installation, and does not cover paint film failure due to the failure of the substrate.
- 3. This warranty excludes failures caused by standing water, and direct exposure to corrosive and aggressive atmospheres including animal waste products. This warranty does not cover failure due to salt spray corrosion.
- 4. Dura Coat's responsibility liability is limited and extends only to the direct cost of refinishing or replacing failed coated substrate and in no event shall Dura Coat's liability exceed the original unit price of the coated metal panels, trim, and flashing. Dura Coat cannot accept liability for loss or damage to other property or equipment, loss of profits or sales, or any other claims relative to standard business interruption, or any other incidental or consequential damages. This warranty does not cover, nor does Dura Coat accept any financial responsibility for tear down, removal or reinstallation of solar panels, or any other attachments previously added to the roof or its surface.
- 5. Dura Coat reserves the right to establish whether repainting or replacing material is required and to approve and participate in the negotiation of any subcontracted material replacement, installation, or refinishing. After replacement or re-finishing, the repaired area will be considered installed as of the original project installation date for the purpose of the application of this warranty. This warranty will be in effect for the remainder of the warranty period applicable to the metal originally coated.
- 6. Claims under this warranty must be submitted in writing within forty-five (45) days of discovery of the warranted performance failure. Upon review, Dura Coat may, at its discretion, choose to remediate said claim under the terms and conditions outlined in the warranty document or inspect the project. Dura Coat requires the opportunity for site failure inspection and investigation. Dura Coat also reserves the right to solely evaluate and determine its obligation under the terms and conditions of this limited warranty.
- 7. METALLION shall maintain, or have access to, adequate records to identify the coil coater, coil numbers, XT-40S identification and date of installation. In the event of a claim, Dura Coat reserves the right to inspect all records mentioned above.
- 8. This warranty is extended to METALLION alone at the purchase of the coating system and shall not inure to the benefit of any other party. Dura Coat's warranty and name(s) are not to be used in any warranty given by METALLION. This warranty is non-transferable and non-assignable by METALLION, and METALLION shall not permit its agents, representatives, customers, distributors, applicators, or contractors to claim, represent, or imply that this warranty extends to or is available to anyone other than METALLION. Dura Coat is not responsible for any warranty METALLION chooses to provide to its customers concerning the performance of Dura Coat's XT-40S.

- 9. Dura Coat reserves the right to terminate this warranty at any time upon thirty (30) days advance notice, except with respect to any XT-40S which has already been shipped to METALLION. This Limited Warranty automatically expires upon any change or transfer of ownership of the property on which the metal coated with XT-40S is originally installed
- 10. This limited warranty supersedes any and all other warranties of performance, expressed or implied, by Dura Coat. Any modifications, additions, or adjustments made to this warranty must be officially added as a signed written amendment.
- 11. This limited warranty shall be governed by and interpreted in accordance with, the laws of the State of Alabama.
- 12. Dura Coat Products, Inc. and the METALLION have signed this Agreement as of the date set forth below. This agreement is not in effect unless METALLION counter signs and returns the warranty within 30 days of Dura Coat signing this agreement.
